### LIMITED LIFETIME WARRANTY

Should any products purchased from Polar Shades become defective, we will replace or repair them free of charge under the following terms of our limited lifetime warranty. You must activate your Warranty by mailing the Warranty Registration Card located on the back of this pamphlet within 30 days of installation. This Warranty is non-transferable.

**POLAR SHADES' INTERIOR AND EXTERIOR SHADES** are guaranteed to function free from defects in workmanship and materials, under proper use for a lifetime.

**FABRIC** is guaranteed from becoming unserviceable due to: loss of color or strength from normal exposure conditions, including sunlight, mildew, rot and atmospheric chemicals, from original date of purchase for a minimum of 5 years or the fabric manufacturer's warranty period.

**OPTIONAL MOTORS, CONTROLS & ELECTRONICS** are warranted to be free from defects in materials and workmanship, under normal and proper installation and use, for a period of five (5) years from the original date of purchase. Warranty does not cover replacement batteries for remotes or 12Volt motors.

Further, this warranty is void if the screen/shade is sold, serviced, or repaired by any unauthorized dealer or service outlet. Purchaser shall defend, indemnify, and hold Polar Shades harmless against all claims, suits, proceedings, losses, liabilities, and damages (including costs, expenses, and reasonable attorneys' fees) asserted by third parties against the Purchaser which arise out of any act or omission that constitutes a breach of Purchaser's warranties hereunder.
